GGLC COVID PROTOCOLS

1. Hereby release, waives, discharges and covenants not to sue the Golden Gate Lotus Club, Inc. (GGLC), the GGLC chapter clubs GGLC officers, promoter(s), participants, racing association, sanctioning organization(s) and subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and leasees or premises used to conduct the event and each of them, their officials and employees, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence or the releasees or otherwise while in the undersigned is in or upon the restricted area, and/or, competing, officiating, observing, working for, or for any purpose participating in the event.
2. Hereby agrees to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.
3. Hereby assumes full responsibility for and risk of bodily injury, death, or property damage due to the negligence of releasees or otherwise while in or upon the restricted areas and/or while competing, officiating, observing or for any other purpose participating in the event.
