Directions from Hwy 101 in South San Jose

- Head on Hwy 101 to South San Jose
- Continue on Hwy 101 to Blossom Hill/Silver Creek Valley Rd, Exit# 378
- Exit Hwy 101 onto Blossom Hill/Silver Creek Valley.
- At the end of the off ramp (signal) –
 - If southbound turn RIGHT onto Blossom Hill
 - If northbound turn LEFT and cross over Hwy 101
- LEFT at Poughkeepsie (1st signal)
- RIGHT onto Cottle Rd (signal)
- Go about 1 block and LEFT into Parking Lot (European Wax Center)
- RIGHT at the 1st Aisle (Chase Bank)
- Starbucks is straight ahead, look for the group.

We will depart Starbucks at 9:00 sharp.

1. Hereby release, waives, discharges and covenants not to sue the Golden Gate Lotus Club, Inc.
